TOP 1 - GENERAL INFORMATION OTD-S DATA & TICKETING IN HERAPRO

OTD-S = On Time Delivery Supplier



TOP 1 – GENERAL INFORMATION OTD-S DATA & TICKETING IN HERAPRO

OTD-S...

- > ... is a measure of process and supply chain efficiency
- > ...measures the amount of purchased goods delivered to Heraeus on time and completely
- > ...helps determine how efficiently Heraeus suppliers are meeting confirmed delivery dates

Calculation

- > Measurement of delivered PO item / schedule lines:
 - > Comparison of Goods receipt posting date vs. statistical delivery date of PO schedule line

Goods receipt date	= statistical delivery date of PO schedule line	\rightarrow punctual	(ontime)
Goods receipt date up to 5 working days	< statistical delivery date of PO schedule line	→ ≤5 days too ea	arly <i>(ontime)</i>
Goods receipt date more than 5 working days	< statistical delivery date of PO schedule line	ightarrow too early	
Goods receipt date	= statistical delivery date of PO schedule line + 1 working day	\rightarrow 1 day late	(ontime)
Goods receipt date	> statistical delivery date of PO schedule line + 1 working day	→ too late	

Total number of PO schedule lines on time (punctual + 1 day too late + 5 days too early due in reporting period)

OTD-S =

Total number of completely delivered PO schedule lines (due in reporting period)

TOP 1 – GENERAL INFORMATION OTD-S DATA & TICKETING IN HERAPRO

> Basic information regarding OTD-S data transferred to HeraPro

- > Data transfer update once per week (YTD data & detailed data) (Monday morning 5 am)
- > Data transfer considers completed previous week
- > Changed data of previous weeks will be updated (overwriting of historical data)
- > Benefits for Supplier:
 - > Continuous tracking of delivery performance (so far only once per year by supplier evaluation)
 - > Basis for understanding supplier performance results and to identify unjustified negative ratings
 - > Basis for root cause analysis and continuous improvement of supplier performance

TOP 3 – OTD-S DATA – SUPPLIER VIEW

Purpose

> Publish weekly updated OTD-S YTD rate and related PO lines to continuously track own performance and identify unjustified ratings

View supplier OTD-S data by

- 1) Select Supplier Portal dashboard
- 2) OTD-S tables for aggregated & detailed data are displayed automatically
- 3) View OTD-S Aggregated Data
 - OTD-S rate in % current week (CW)
 - OTD-S rate in % (YTD)
- 4) View OTD-S Detail Data
 - Selected details directly displayed in dashboard, full data set available under "(i) More"

TOP 5 – OTD-S TICKET (INITIATED BY SUPPLIER)

Purpose

- Contacting Heraeus buyer to clarify OTD-S rate or detailed purchasing data, e.g. in case of unjustified negative OTD-S rate for a dedicated PO line
- > Ticket can be issued for
 - Unjustified OTD-S rating
 - Statement OTD-S (stating reasons and counter measures for improvement proactively)
 - Master data clarification (e.g. planned delivery times, Incoterms)

TOP 5 – OTD-S TICKET (INITIATED BY SUPPLIER)

How to handle an OTD-S clarification ticket

1) Choose *Clarification OTD-S*

2) Add ticket subject

- \rightarrow for better identification of ticket in ticket overview, e.g. OTD for PO 4000123456 unjustified
- 3) Choose request reason out of drop down
- Choose request recipient Heraeus out of drop down (list of all existing Heraeus buyer^{1,2})
- 5) Add Purchase Order reference (optional)
- 6) Add a **detailed description (comment)** for the reason of issuing the ticket
- 7) Attach related documents (optional)
- 8) Choose action
- a) "Save" to store the current state as a draft
- b) "Send to supplier" to issue the ticket to the selected supplier
- 9) Click "**Save**" to confirm the ticket and trigger ticket notification to the supplier contact person

¹ if a responsible buyer is maintained, ticket will be prefilled by responsible buyer

² if a dedicated PO has been selected, ticket will be prefilled by the buyer who issued the PO
